Resolution to override tax cap	Ellen Dellostritto read aloud the "Resolution to Override the NYS Tax Cap for Proposed 2023 Budget" as follows:  Whereas, the adoption of this 2023 budget for Seymour Public Library District requires a tax levy increase that exceeds the tax cap imposed by state law as outlined in General Municipal Law Section 3-c adopted in 2011; and  Whereas; General Municipal Law Section 3-c expressly permits the library board to override the tax levy limit by a resolution approved by a vote of sixty percent of qualified board members; now therefore be it  Resolved, that the Board of Trustees of Seymour Public Library voted and approved to exceed the tax levy limit for 2023 by at least sixty percent of the board of trustees as required by state law on Tuesday, August 23, 2022.
