Election/Budget Referendum- talking points	Review of answers to possible questions from voters: taxes currently 40.70 per 100,000 assessed valuation. Proposed 43.52 per 100,000 assessed valuation.		
Grants Review (Dori Gottchalk-Fielding)	Received a grant of 45,000 by the City out of federal coronavirus funds to cover development of the library's outside spaces, including extending Wi-Fi services, seating, and the services of a landscape architect. Have until 2026 to expend funds and complete the project. PLA grant of 7000 for digital literacy series of workshops.		
Dunn Bequest	Lisa Carr reported that the Dunn bequest balance is 802,951. Approximately 550,000 still owed on West Lobby project, with 100, 000 directed to operating deficit this year and next.		
Open Meeting Law	Relaxing of Open Meeting Law has ended, meaning only extraordinary circumstances will be allowed for meeting participants to zoom in: illness, disability and care of a sick family member.
