And, Jackie, you probably told the Board Governance Committee this information. But the background is I talked to our lawyer about how how do we run our election in the pandemic, right. And if people can't we don't we didn't know. Could we have people in the building to vote or not vote? So as you know, she always has to go back to what does our legislation say? And our legislation pretty vague. So then it had some things in there and somethings not in there. And then she went and looked at what the school districts do, what does other special districts do and came up with some information. So our legislation does say that we're supposed to have an election chair for each municipality. But we've never done that. I think that might have happened in the first election. When we you know, the votes were held in Throop and Aurelius and all of that, but as far as I know, we haven't done that. So since that hasn't been practice, the lawyer felt that having an election chair appointed by the board is where to the school district appoints the school district board appoints a clerk. The school clerk or, or the town, the town clerk. So that's really what we're going to be asking the board to appoint Jackie to act as the election chair. So Jackie fill in whatever I left out.

  - I feel like you covered everything. Um, the election chair, pretty much does what I already do, um, gets everything organized for the election arranges all the details, um, gets all the legal ad set on time. Um, so now it would just be official. Um,

  and we see, this is the first time we're talking about absentee ballots. And so that's what made this a little bit more. We had to be more official. And so the election chair's also responsible for receiving absentee ballots. Yes,

  - yes, well, actually, right, yes, they're sent to me on they can be received at the main desk, received or recorded at the main desk, by library staff, but I handle all of the details and make sure all of the pieces that are there in play with that, but we did receive instructions from the lawyer that said that they can be received at the desk by any library staff member, and we just have to record when they came in. I'm working on detailed staff instructions right now. I have contacted Jacobs Press are printing our official ballot envelopes. So those should be ready. And the lawyers told us that we can have the ballots in the absentee ballot application and the absentee ballots available starting on September 28, 30 days before the election takes place. So we what we can do is we'll have absentee ballots available for pickup at the main desk starting on that date. We also were told that we can have a PDF or like downloadable form on our website. So people who are interested can can print that at home and fill out the form and bring it in and then from there we check. We'll have a voter registration list and we check that make sure that they're registered to vote for whatever district whatever trustee they're voting for. And from there, we give them an absentee ballot. And then there's a variety of other rules that we have to follow, which I did create. I just shared with Lisa updated timeline. So I can make that into a PDF. And Lisa, if you want to share that with everybody after the meeting, but it just has those deadlines for when we can start when they can be available the absentee ballots. How you can receive the deadline for requesting ballots by mail, the deadline for returning the absentee ballot application for in person pick up forms. And there's still a lot of little pieces that we organize with the lawyer and we're putting into process.

So that's the grant that I applied for, to renovate the West lobby, Finger Lakes recommended our funding at \$288,194. The total project cost is \$511. And we had asked for 75% funding, and this is 62% funding. So I need to let Finger Lakes know whether we're okay with receiving not the 75% with a lesser amount. This amount the library would be responsible for is 223,000. And that is within the range that we had talked about a 50/50 grant match. It's a little bit less because we're getting the 62%. So are there questions? That's a lot of numbers. I just threw out.

getting them in. And so then once I have all of the candidates names, I will take the legal ad from the lawyer, which I'm I'm waiting on, I just sent him an email. Um, and I will add those in and that will be announced in this Sunday's Citizen, that will be the legal ad announcing the availability of the trustee petitions. Um, we have a couple different legal ads. The election is October 28. Wednesday, October 28, I just hired the election inspectors, um, Pat and Jim, they are coming back. So they agreed to do that. I'm meeting with Dori next week, because we're going to talk about all of the health and safety regulations and kind of walk through the space, I'll make sure that we have everything in correctly set up in proper signage. - Jackie Kolb 19:02 she's gonna help me make those plans. Um, like Lisa said, the kind of the extra layer to this year is the absentee ballots. Um, so as far as that process goes, they will be available starting Monday, September 28. You have to you have a couple options with those. So the

absentee ballot application will be available on our website, and at the main desk. So you can either go to the website or the desk to pick that up. People can then fill it out right there in person if they want and receive the absentee ballot immediately, um, they can take the application home and either bring it back to us or mail into us, mail it back to us. But you have the option to request that the ballot be mailed to you or just pick it up in person. So both of those have different deadlines. If you're requesting that it be mailed to you. The deadline is seven days before the election. Um, if you are just going to pick it up in person, you can pick it up one day before the election. Um, so a couple different timelines for that, um, and Dixie, I can mail you or email you the timeline with these things I'm mentioning. I don't know if you need that for your notes.

Um, so that's kind of what we're working through to finalize right now. And then there is no budget referendum this year, so we didn't have to add that piece in

  - So um, you actually can't just call and request an absentee ballot be mailed, you have to submit an absentee ballot application. So you have until October 21 to get the application into the library. And we can mail the absentee ballot no later than six days before. That's the timeline the lawyer gave us so I would get all of the final requests on the 21st. And then I would mail them immediately out in the morning of the 22nd. Do you have to add that to the timeline? Um, that's what they told us was standard practice. Um, so that's, that's what we're following.

And right on the absentee ballot is that it is due at the library by 5pm on the day of the election. So if someone reads that and doesn't think it will get mailed in time, they can bring it in. I mean, yes, people can bring in the absentee ballots on the day of the vote um someone who has already submitted an absentee ballot can vote that day of the election, but then as the votes are getting counted, their absentee ballot will be discarded or voided. But so there's Yeah, those are the little details that I'm working in the instructions for the inspectors, and then the instructions for staff.

One of the things that I noticed wasn't really reflected in our minutes from last last time was the fact that there was discussion about going forward with the roof, but there was no confidence that that foundation could act in time in order to put together some kind of a financial strategy and, and approve a roof project a million dollar roof project in such short notice. So the reason we went ahead and approvde the West lobby project was because first of all, it didn't involve any money coming from the foundation. And secondly, that package was ready to go at the same time. So both packages ready to go. And then thirdly, neither project is related to one another so one does not depend on the other. So, you know, when we had the emails that went round and round, and the notion that well, you know, maybe the foundation will put in 300. And we'll take 300 out of the Dunn money and all

that. I mean, that was just, I was just way too late for any of that to take place. So I think in that meeting, Lisa, I mean, with between Guy and Nancy, and you and I, you and me, we, we kind of decided that we one needed to have a meeting, set up a meeting to talk specifically about the ownership and transfer the ownership. And I think coupled with that will be a conversation about Okay, then how do we get the roof done? And what's the foundation's role in doing it? So that meeting is scheduled for next week. I think either Wednesday or Thursday, something in there.
