Wednesday, Sept. 4: Publicize & host a trustee informational session (6 p.m.)

Tuesday, Sept. 17: 5 p.m. Deadline for trustee candidates to submit petitions (36 days before)

**Tuesday, Sept 24:** Place legal notice to advertise availability of Absentee Ballots (NO EARLIER than 30 days before) & notice of public hearing on referendum

Tuesday, Sept. 24: Letter from Board to municipalities, re: Public Hearing & Copy of Annual Report

Wednesday, Oct. 2: Hold public hearing on budget (21 days before) (6 p.m.)

Thursday, Oct. 3: Earliest Date to place legal notices/signs in municipal buildings advertising

Election/Referendum(20 days before)

Thursday, Oct. 3:Place legal notice announcing the date of the Budget Referendum/Trustee Election

Thursday, Oct. 3: Email from the Board to municipalities, re: Budget Referendum & Election (legal notice sign)

Thursday, Oct. 10: Last day to place legal notice/signs in municipal buildings (13 days before)

Wednesday, Oct. 16: Deadline for Absentee Ballot Applications requesting ballot by mail (7 days before)

Thursday, October 17: All Requested Absentee Ballots must be mailed out (6 days before)

Tuesday, October 22: Deadline for Absentee Ballot Applications for in-person ballot pick up (1 day before)

Wednesday, October 23: Election Day. Completed Absentee Ballots must be returned by 5 p.m. (day of vote)
